New Business: Albany County Sheriff's Office, 6419 Route 32, Greenville, NY 12083. Steven Elsbree present on behalf of the Albany County Sheriff's Office. They are looking for a special use permit for installation of public safety communications facility co-location within an existing telecommunications compound area. Installation of a 60' extension to the 80' existing monopole tower and installation of a 12X16' communications building. Application assigned #15-003. Adoptive comprehensive plan-negative declaration. A public hearing has been scheduled for this application for August 25, 2015. Site visit scheduled for August 11, 2015 at 6:30 pm. Steven Elsbree received letters to send to the abutters. Richard Kurylo made motion to accept application; Gerry Boone seconded the motion. All members present in favor.

Albany County Sheriff's Office, 158 Goodfellow Rd, Westerlo, NY 12193. Steven Elsbree present on behalf of the Albany County Sheriff's Office. They are looking for a special use permit for installation of public safety communications facility co-location at an existing 150' monopole. Installation of a 12X16' communications shelter within the existing equipment compound. Application assigned #15-004. Adoptive comprehensive plan-negative declaration. A public hearing has been scheduled for this application for August 25, 2015. Site visit scheduled for August 11, 2015 following the Route 32 location. Richard Kurylo made motion to accept application; Doyle Shaver Jr. seconded the motion.
