This meeting was held at the Westerlo Town Hall, 933 County Route 401 Westerlo, NY 12193 and via Zoom.

Dave Lendrum, Jill Henck, Bill Scrafford, and Supervisor Bichteman were present at Town Hall and Kelley Keefe and John Sefcik joined via Zoom. Noah Zweifel of the Altamont Enterprise also joined via Zoom.

- I. Dave made a motion to approve improved minutes provided by John Sefcik, see below, Jill seconded the motion, all members present voted in favor.

- II. Dave suggested getting the community more involved by hosting subcommittee meetings on Zoom. The Committee agreed to schedule all subcommittee meetings ahead of time in order to make them more readily available to the public. Supervisor Bichteman said the Hudson River Valley Greenway grant, which the Town had been approved for, is no longer available because of Covid-19 related budget cuts. Bill Scrafford asked about the Ag and Markets grant, and Supervisor Bichteman said the Town is no longer moving forward with that process because they aren't going to put together agricultural plan, which the grant requires. Supervisor Bichteman said he would ask the Town Board about funding at their upcoming meeting. After a discussion regarding logistics for mailing the survey, Supervisor Bichteman said tell him what the Committee needs for the mailer and Town Staff can take care of it.
- IV. The Committee analyzed and amended draft survey questions, included below.

review, John seconded, all members voted in favor. Bill made the motion to expedite Chuck Voss's comments to be approved by the CPC chairman for approval and then be sent to Bill and Town staff for formatting and printing. Jill seconded the motion and all members voted in favor.

- V. Bill asked if the Town Board should replace Sue on the committee, after discussion there was no opposition to this suggestion.
- VI. For the May 27, 2020 CPC Meeting members would continue working on inventories for old topic areas and assembling questions for designated subcommittee meetings. Jill made a motion to adjourn at 9:10 pm, Bill seconded the motion, all members voted in favor.
