PUBLIC HEARING FOR MARCELLO VARIANCE (V-22-2)

ZBA Member Spahmer made a motion to open the Public Hearing at 7:02 PM. ZBA Member Weidman seconded: all were in favor.

Mrs. Albers who currently owns property located at 450 Maple Ave Ext and her granddaughter came to express their concerns about Mr. Marcello putting up a garage. They are concerned that the garage is going to be a nuisance to their property. It was implied that their property is woods and over grown. The Albers explained that if one of their family members wanted to build on the property in the future that having the garage so close to their property line would be an eye sore. Mr. Marcello indicated that the garage which would be 24' x 36' x 9' would not be seen from their property. Ms. Albers stressed to the Board that she hopes that they think about their decision with legalities in mind. Mrs. Albers asked the Board if they would like to come out and look at the site but from her property. ZBA Chairman VanIderstine asked the Board if they would like to do that. Most members said yes. They would all go out at different times when all had a chance. Mr. Gallogly wanted to go on the record that he really doesn't like group site visits with the homeowners. Chairman VanIderstine did explain that there are other ways for Mr. Marcello to be able to build on his property. ZBA Member Spahmer asked how much of a difference it would be to change the layout of the garage. The Board did discuss that there are other building options over on the other side of the property. ZBA Member Spahmer asked Mrs. Albers to take
